

**Rockcastle County Fiscal Court
Special Called Meeting
June 19, 2014**

Judge Carloftis called the meeting to order with the following present: Squire Adams, Squire Allen, Squire Denny, and Squire McKinney. Also present were County Attorney, Billy Reynolds, County Treasurer, Joseph Clontz, and Fiscal Court Clerk, Patricia Martin. Absent: Squire Burdette

APPOINT MEMBER TO BOARD OF ASSESSMENT Motion was made by Squire Denny, seconded by Squire Adams, with all voting aye to appoint Tim McKinney to the Board of Assessment.

BUFFALO HOLLOW ROAD Some Residents on Buffalo Hollow Road were at the Fiscal Court meeting to ask if a speed limit could be set at 15 mph on Buffalo Hollow Road. In the previous meeting a speed limit was set at 35 mph. Motion was made by Judge Carloftis, seconded by Squire Adams, with all voting aye to lower the speed limit on Buffalo Hollow Road to 20 mph.

ELECTRICAL INSPECTORS & INSPECTIONS Motion was made by Squire McKinney, seconded by Squire Adams, with all voting aye to set the Electrical Inspectors Inspections fee at \$70.00 for residential, temporary, single family, multi family, mobile homes, additions, change outs, reinspections for electrical work and 1% for electrical commercial inspection.

BRETT D. WILLIAMS Motion was made by Squire Denny, seconded by Squire McKinney, with all voting aye to add Brett D. Williams as an electrical inspector for Rockcastle County.

CLAIM – EADS FENCE COMPANY Motion was made by Squire McKinney, seconded by Squire Denny, with all voting aye to pay \$16,300.00 for fencing at the ball field.

CLAIM – RCIDA Motion was made by Judge Carloftis, seconded by Squire Allen, with all voting aye to pay \$786.38 to RCIDA for expenses.

CLAIM – SEARS GLASS Motion was made by Squire Denny, seconded by Squire McKinney, with all voting aye to pay Sears Glass \$470.81 for new glass at the Clerk's office.

SECOND READING AND FINAL ADOPTION OF ROCKCASTLE COUNTY FISCAL COURT 2014 – 2015 BUDGET Motion was made by Squire Denny, seconded by Squire McKinney, with all voting aye to approve the second reading and final adoption of the Rockcastle County Fiscal Court 2014-2015 budget.

ROGER RUCKER Roger Rucker was at the Fiscal Court May Fiscal Court meeting to ask for payment for his fence on Lambert Road. The Fiscal court approved paying Roger Rucker \$7,900.00. Mr. Rucker turned in a claim for \$8,900.00 and was told that \$7,900.00 had been approved. He then submitted a claim in the amount of \$7,922.60 and was told the court had only approved \$7,900.00 and he refused to accept the check. Motion was made by Squire McKinney, seconded by Judge Carloftis, with all voting aye to rescind the motion and void the check.

TRANSFERS Motion was made by Squire Denny, seconded by Squire McKinney, to approve the Intra Fund transfers as submitted. (See Attached)

CLOSE SESSION

Motion was made by Squire Allen, seconded by Squire Denny, with all voting aye to enter into close session.

OPEN SESSION

Motion was made by Squire Allen, seconded by Squire McKinney, with all voting aye to enter into open session.

Motion was made by Squire Allen, seconded by Judge Carloftis, with all voting aye to purchase the Donald Rice property for \$12,000.00. The property is located in Livingston between 2 county owned properties.
