Howell Holbrook, CSEPP Director Howell Holbrook discussed with the Judge and magistrates about Codell Construction, construction managers for the new emergency services building. They asked for an increase in their fee since the project went from 1.5 million to over 1.9 million. The contract was for \$115,000.00 originally but they were requesting it to be raised to \$145,700.00. Howell was going to look at the original contract to see what the percent was agreed upon.
