MINUTES OF FEBRUARY 10, 2015 Motion was made by Squire Denny, seconded by Squire McGuire, with all voting aye to approve the minutes as read.

**MINUTES OF FEBRUARY 26, 2015** Motion was made by Squire McGuire, seconded by Squire Bishop, with all voting aye to approve the minutes as read.
