Judge Bishop called the meeting to order with the following present: Squire Burdette, Squire Bishop, Squire McGuire, Squire Denny and Squire McKinney. Also present: Jeremy Rowe, County Attorney, Joseph Clontz, County Treasurer and Patricia Martin, Fiscal Court Clerk.

OPEN BIDS FOR FIRE TRUCK Bids were opened from the following for a fire truck for Mt. Vernon Fire Department:

No Action was taken.

TAMMY CAMPBELL, FCCLA Tammy Campbell, Family and Consumer Services Teacher was at the Fiscal Court to ask for a donation to FCCLA who placed first in three different categories at the state leadership conference in March, and six of the students are advancing to the national competition in July in Atlanta, GA. ROCKCASTLE COUNTY CONSERVATION DISTRICT 2018 – 2019 BUDGET & PLAN OF WORK – SANDY WHITAKER, DISTRICT CLERK AND ROY REYNOLDS, CHAIRMAN Sandy Whitaker, District Clerk and Roy Reynolds, Chairman was at the Fiscal Court to present their 2018 – 2019 Budget and Plan of Work. They told the fiscal court about the different programs that was being offered in the county. Motion was made by Squire Denny, seconded by Squire McGuire, with all voting aye to approve the budget as presented.

SHERIFF'S OFFICE EQUIPMENT Dale McNew, Sheriff's office was at the Fiscal Court to discuss the new vehicles they are expecting. The 2 new vehicles will be arriving sometime in June and the fiscal court will have to pay the \$63,600.00 for them and then will be reimbursed \$34,866.00 from a grant they received to purchase the vehicles. Motion was made by Squire McGuire, seconded by Squire Bishop, with all voting aye to pay \$24,600.00 to equip the 3 other vehicles they had purchased earlier.

ADDITIONAL BOND CLAIM Motion was made by Squire McGuire, seconded by Squire Burdette, with all voting aye to pay the bonds for additional deputies for the sheriff's office in the amount of \$41.74.

ROCKCASTLE COUNTY LIBRARY BOARD 2 POSITIONS Motion was made by Squire McKinney, seconded by Squire Denny to appoint Misty Ewing and Barbara Congleton to the Rockcastle County Library Board for a term of 4 years starting July 1, 2018.

QUAIL PARK REPORT Motion was made by Squire Burdette, seconded by Squire McGuire, with all voting aye to approve the reports as presented.

SOLID WASTE REPORTS Motion was made by Squire Bishop, seconded by Squire Burdette, with all voting aye to approve the reports as presented.

SIGN LEASE AGREEMENTS WITH WESTERN ROCKCASTLE FIRE DEPARTMENT & BRINDLE VOLUNTEER RIDGE FIRE DEPARTMENT Motion was made by Squire McGuire, seconded by Squire Burdette, with all voting aye to sign a lease agreement with Brindle Ridge Volunteer Fire Department and Western Rockcastle Volunteer Fire Department. The term of this lease shall be for a period of (1) year, commencing on May 8, 2018, however they shall have the option to extend this lease on a year to year basic.

LIVINGSTON FIRE DEPARTMENT – REIMBURSEMENT FOR BILLS Motion was made by Squire McGuire, seconded by Squire Burdette, with all voting aye to reimburse Livingston Fire Department \$1,904.05 for equipment for new fire truck.

MONTHLY FINANCIAL REPORT Motion was made by Squire Burdette, seconded by Squire Bishop, with all voting aye to approve the monthly financial report as presented.

3RD QUARTER FINANCIAL REPORT Motion was made by Squire Bishop, seconded by Squire McGuire, with all voting aye to approve the 3rd quarter financial report as presented.

REIMBURSE OCCUPATIONAL TAX Motion was made by Squire McKinney, seconded by Squire Denny, with all voting aye to reimburse over payment of occupational tax in the amount of \$2,192.00.

REIMBURSE INSURANCE TAX Motion was made by Squire McKinney, seconded by Squire Bishop, with all voting aye to reimburse over payment of insurance tax in the amount of \$50.64.

FIRST READING OF ORDINANCE – BORROWING \$1.425 MILLION FOR MICROFOODERY Motion was made by Squire Bishop, seconded by Squire McGuire, with all voting aye to approve the First Reading of Ordinance approving a lease for the financing of the construction, installation and equipping of a building for Microfoodery in the principal amount not to exceed \$1.425 million.

HIRING OF CPA TO DO AUDITS Information Only.

LIVINGSTON PROGRAM SUPPORT Mike McGuire, Magistrate asked the fiscal court to give City of Livingston \$5,000.00 to do repair work on their city streets. Motion was made by Squire McGuire, seconded by Squire Bishop, with Squire Bishop, Squire McGuire voting aye and Squire Burdette, Squire Denny and Squire McKinney voting nay. Motion failed.

After more discussion motion was made by Squire McGuire, seconded by Squire Bishop, to give City of Livingston \$5,000.00 in program support with Squire Burdette, and Squire McGuire and Squire Bishop voting aye and Squire Denny and Squire McKinney voting nay. Motion carried.

TRANSFERS Motion was made by Squire McKinney, seconded by Squire Bishop, with all voting aye to transfer \$200,000.00 from Occupational Fund to General Fund, and transfer \$50,000.00 from General Fund to Jail Fund.
