**PERSONNEL**


Motion was made by Squire McGuire, seconded by Squire Bishop, with all voting aye to give all county employees with 3 years and above seniority \$1.00 per hour increase. All employees with less than 3 years seniority \$.50 per hour increase with remaining \$.50 when they reach 3 years in seniority. Also the starting wage for 911 will increase from \$9.00 per hour to \$10.00 per hour and the 2 full time new hires pay will increase \$1.00 per hour. Jeremy Rowe, County Attorney, Kathy Robinson, County Attorney Secretary, Joseph Clontz, County Treasurer, Mark Blanton, Road Supervisor, Tracy Smith, Jail Deputy Supervisor, Howell Holbrook, CSEPP will receive a \$2,080.00 year increase in pay. Bonnie Roark, 911 Director will receive \$2,080.00 per year increase in pay with the court agreeing to revisit at a later date. The new increase will begin on September 22, 2017.

Motion was made by Squire Bishop, seconded by Squire McGuire, with all voting aye to give David Colson a \$2,080.00 per year increase in pay but also require him to work 3 additional hours per week for a total of 18 hours per week.

Motion was made by Squire Bishop, seconded by Squire McKinney, with all voting aye to change Coy Cromer's position from Assistant Road Supervisor to Work Release Supervisor and to reduce his pay to \$14.87 per hour including the \$1.00 per hour increase.

Motion was made by Squire McGuire, seconded by Squire Bishop, with all voting aye to add to the administrative code changes concerning compensation to new road employees. All new hired employees' compensation will be based on experience, CDL's, and skill.
