Regular Called Meeting  
October 11, 2022**

Judge Holbrook called the meeting to order with the following present: Squire Thacker, Squire Bishop, Squire McGuire, Squire Denny, and Squire Prewitt. Also present: Sheriff Shannon Franklin, County Attorney Assistant William Leger, Treasurer Joseph Clontz and Fiscal Court Clerk Vickie Miller.

**MINUTES OF SEPTEMBER 12, 2022** - Motion was made by Squire Bishop, seconded by Squire Denny, with all voting aye to approve the minute as presented.

**MINUTES OF SEPTEMBER 29, 2022** - Motion was made by Squire Prewitt, seconded by Squire Thacker, with all voting aye to approve the minute as presented.

**ROCKCASTLE COUNTY INDUSTRIAL AUTHORITY REPORT** – Motion was made by Squire Bishop, seconded by Squire Thacker with all voting aye to accept the RCIDA’s monthly budget showing a surplus of \$5,292.77.

**TRANSFER** - Motion was made by Squire Denny, seconded by Squire Prewitt with all voting aye to approve the transfers of \$230,000 from Occupational Tax to General Fund, \$30,000 from General Fund to LGEA Fund, \$10,000 from General Fund to the Jail Fund, \$15,000 from General Fund to 911 Fund and \$12,159.27 (FEMA deposit) from Federal Funds to the Road Fund.

**911 EMPLOYEES** – Brittney Moore questioned the court about any updates on the responses she received at the last court meeting, specifically about the Health Insurance invoice and the addition of a fee on county water bills. Judge Holbrook explained, again, we have not received the first invoice for the health insurance and County Attorney Jeremy Rowe is looking into the fee on the water bills. Jessica Cameron addressed the court about the wages at the 911 center and asked for an increase in those wages. Judge Holbrook explained until the court knows what the Health Insurance is going to cost for the new Fiscal Year, the court could not look at wage increases for all employees.
