

**Rockcastle County Fiscal Court
Workshop
February 13, 2023**

Roads

1. Secluded Ridge Rd residents Linda Hill and William Rohrer addressed the Court concerning their road. Ms. Hill said it was unsafe to travel safely on it. She wanted the County to repair and maintain the road. She said the developer had turned it over for public use on the plat. Judge Holbrook explained that public use does not mean it automatically becomes a county maintained road. Judge Holbrook stated that Secluded Ridge was a plated subdivision and there are requirements that must be met before the County would consider taking in subdivision roads. He gave her a copy of our subdivision requirements and it cannot be brought into the county maintained system unless it is brought up to the county's statutes.

County Buildings

1. Debbie Brown from the Rockcastle County Historical Society and Museum address the court informed the court of the gift, from the Lambert family, of the two story building on Church Street across from the Courthouse. She stated it was in need of repairs and asked the Fiscal Court for financial assistance for the renovation of the building. She handed out a quote of \$79,800 from Ricky Hatfield for the remodel. She said this building would provide a place where residents could come and look up their genealogy or look at the history of our county. She is also going to ask the City of Mt. Vernon for assistance.
2. Lawrence Thayer "Colonel Sanders" addressed the Court about using the two rooms of the Livingston School for his Colonel Sanders and train collection. He thought it would be a great asset to the community.
3. Larry Davidson, Mayor of Livingston asked the Court to consider allowing the City of Livingston to manage the Livingston School building and the 3 classroom building. He also asked the court to re-think selling the 40 acres of land at Livingston. He thinks Livingston could use the land as a tourist attraction with trails and bouldering available to the public.
4. Each magistrate was given a copy of Glenna Robinson's letter concerning her use of the Livingston School Building for her Haunted House.

Grants / Donations

1. Discussed the Clerk's E-Pol Books quote of \$58,015 from Election Systems and Software. This system is needed because the current system's contract has ended. There is a grant available for \$35,700 that would reimburse the county. A resolution and an agreement will need to be approved.
2. RCIDA's ARC grant has made the final deposit of \$50,000 into our Federal Funds and will need to be transferred to their ARC Grant account.
3. CVADD will be holding a Public Hearing on 2-14 at 3:30 pm to hear comments on the 50/50 grant for the Ballfield at Brodhead they are applying for.


Fiscal Court Finances
