Regular Called Meeting  
December 10, 2024**

Judge Holbrook called the meeting to order with the following present: Squire Thacker, Squire Adams, Squire McGuire, Squire Denny and Squire Prewitt. Also present: County Attorney Jeremy Rowe, Jailer Nathan Carter, Sheriff Deputy Ron Bradley, Fiscal Court Clerk/ Treasurer Vickie Miller and Fiscal Court Clerk/ Treasurer Trainee Kelly Ponder.

**MINUTES OF REGULAR MEETING NOVEMBER 12, 2024** – Motion was made by Squire Thacker, seconded by Squire Adams with all voting aye to approve the minutes as presented.

**MINUTES OF SPECIAL MEETING NOVEMBER 26, 2024** – Motion was made by Squire Denny, seconded by Squire Adams with all voting aye to approve the minutes as presented.

**COUNTY CLERK DANETTA FORD ALLEN-CLERK’S BUDGET AND MAXIMUM SALARY**-Motion was made by Squire Thacker and seconded by Squire McGuire with all voting aye to to approve the County Clerk’s 2025 Budget as presented. Motion was made by Squire Prewitt and seconded by Squire Denny with all voting aye to approve the Maximum Salary set at \$269,000.00 for 2025.

**DALE MCNEW-SHERIFF’S BUDGET AND MAXIMUM SALARY**- Motion was made by Squire Thacker and seconded by Squire Prewitt with all voting aye to approve the Sheriff’s 2025 Budget as presented. **CLAIMS**- Motion made by Squire Denny and seconded by Squire McGuire with all voting aye to approve all claims as presented.


**TRANSFERS-**

-Motion made by Squire McGuire and seconded by Squire Denny with all voting aye to approve a transfer from General Fund to CSEPP Fund for \$243.94. This is due to an error of the Jackson Energy Utility Bill for the Animal Shelter being paid out of the CSEEP fund instead of the General Fund.
